

CITY & Zone 1

(Cities of St. Johns/DeWitt)

Please call day before to arrange for a pickup time closer to your schedule. Same day call-in, picked up as schedule permits.

Usually 1 hour in Zone 1 and 1/2 – 1 hour in city.

Two trips grouped between above times
by request.

Schedule medical trips to return no later than
3:00 pm from Ingham County

GENERAL INFORMATION


- No fare...no ride
- No credit for pass card overpayment
- No show...you pay before next ride
- No smoking, eating, drinking, fuel, weapons or explosives allowed on bus.

Clinton Transit may make several stops, so plan a longer trip time than in a car. The bus may arrive 10 minutes early or 10 minutes after pickup time.

Driver will wait only 3 minutes. Someone else is waiting for the bus too.

All rides are subject to availability.


